Panel 1: Clean Water: Between Two Waterways

- Rob Billot (Partner at Taft Law) will discuss his work on protecting drinking water along the Ohio River from the chemical C8, also known as PFOA.

#### Panel 2: Renewable Energy: Charting Ohio's Path to a Clean Energy Future

- Jane Harf (Green Energy Ohio) will provide an overview of the state of renewable energy in Ohio.
- Dylan Borchers (Bricker & Eckler) will give a practitioner's perspective of representing renewable energy companies through the process of developing their projects.
- Randi Leppla (The Ohio Environmental Council) will discuss how the Public Utilities Commission of Ohio plays a role in creating the landscape for clean energy throughout the state.

#### Panel 3: Oil and Gas Law Drilling Into Oil and Gas Law

- Molly Corey (Capital University Law School) will explain the Ohio Attorney General's role in enforcing oil and gas laws.
- Mike Hopkins (Ohio EPA Division of Air Pollution Control) will explore the purpose and function of air permits in regulating the oil and gas industry.
- Richard Sahli (Richard Sahli Law Office LLC) will give the public interest lawyer's perspective on representing community groups and fracking operation opposing projects that may impact the local environment.
